# Ranch Boards Approve Preliminary Budgets for Fiscal Year 2020

The boards of supervisors for the Lakewood Ranch Community Development Districts (CDDs) approved preliminary budgets for the next fiscal year for their respective districts at their June meetings.

Per state law, which requires a 60-day delay before final budget approval, the final budget votes will take place at their August board meetings.

The supervisors of District 1 appointed L. Robert Dapper, a resident since 2007, to the vacant seat on the board, created when long-time supervisor Gary Berns resigned his position after moving out of the district earlier this year. Berns was presented with a plaque honoring his 15 years of service to the district as a supervisor at an earlier meeting.

Dapper graduated with a degree in accounting from Penn State University, served in the U.S. Army as a finance officer, and went on to spend 31 years with the former Arthur Anderson accounting firm in various capacities, which included setting up a shared services center in Sarasota in the late 1990s.

He then joined United Health Care, where he continued working in human resources, internal management, and recruiting, retiring as senior vice president for human capital in 2007, the year that he and his wife moved to Riverwalk Ridge in Lakewood Ranch.

Dapper has served District 1 on several committees of the Summerfield-Riverwalk Association, including modifications, budget and communications.

The naming of a new supervisor in District 1 has resulted in a change of assignments for District 1 supervisors. Supervisor Alan Roth will take over as chairman of the District 1 board. Bob Swiatek will act as vice chairman and Inter-District Authority (IDA) representative. Dapper will be the new District treasurer. Preston Olinger will be backup IDA rep., as well as assistant secretary and liaison with the HOA. Laura Fox will be secretary and the liaison with the HOA safety committee.

The gopher tortoise survey taken recently in District 1 has been submitted to the Florida Fish and Wildlife Commission.

Regarding the Bluffs neighborhood in District 1, the state has requested more information on the grant application for study and possible work to mitigate erosion.

District 1 chairman Alan Roth reported

that the IDA has received funds from FEMA to compensate the community for money expended in cleaning up after Hurricane Irma.

## VENDOR-LEASED AREAS

The various CDD boards approved new agreements for the leasing of community-owned land at the operations facility to two vendors: Down to Earth Landscaping and Altect Lakes and Natural Areas.

Down to Earth had previously leased land from Lakewood Ranch, but the new agreement increases the space leased, and provides additional revenue to the community.

Altec is a newcomer in leasing land at the operations building. Altec will be leasing an area of about 10,000 square feet for storing their equipment that is used both in and outside Lakewood Ranch. They plan to erect a fence around their area at their own cost, and will leave the fence in place if and when they terminate their use of the property.

### **CELL SERVICE**

Executive Director Anne Ross informed the various CDD boards that, as the community's agreement with USA/CRAN is essentially dead, she will be reaching out to the various major cell phone service providers, such as Verizon, AT&T, and T-Mobile, in order to find out whether their plans include erecting small towers in and around Lakewood Ranch in order to better serve their customers.

Hurricane season is officially upon us. The official season began on June 1 and goes until the end of November. Advance planning and execution is key to hurricane preparation. Here are some tips from CERT, our Lakewood Ranch Community Emergency Response Team, to make sure you, your family, and pets are ready:

Install shutters or precut covers on all windows to protect from wind-driven debris.

**Dupplug and secure** high-value electronics. When lower-Ling a television antenna, be very careful and do not touch power lines due to the risk of electrocution.

**¬** Fill your vehicle's fuel tank as soon as possible to avoid Dlong lines at the gas station. Gasoline may not be available for days or weeks after the hurricane strikes. Gasoline pumps do not work when electricity is out.

**Stay tuned to radio** and television for the latest alerts, warnings, and advisories.

**If your house has a pool**, ensure that it is prepared for  ${f O}$  the storm. Lower the water level to accommodate heavy rains, but do not drain completely. Add extra chlorine to the pool and turn off electrical power to pool equipment.

**6Store water in bathtubs,** barrels, jugs, and other con-tainers. Use this water for bathing and sanitary purposes. Do not use this water for drinking.

**TEnsure that your pets have current vaccinations** and you have this paperwork. It will be required when you check your pet into a pet-friendly shelter, hotel/motel, kennel, or veterinarian office.

Obtain cash rolls of quarters and small bills for use in Ovending machines. Remember that most vendors will not accept checks or credit cards after a hurricane.

Pack non-perishable food and water. Select items that Zrequire no cooking and are ready-to-eat. Include a can opener and plastic disposable utensils.

Pack toiletries and enough personal hygiene sup-Uplies for two weeks.

Pack important documents and papers: birth/marriage certificates, visas/passports, wills/power of attorney, computer disks/system disks with important information, video of household goods and of the interior/exterior of the house, and medications.

**1 Pack clothing, bedding**, and bathing supplies, in-Lacluding pants, shirts, undergarments, socks, pillows, sheets/blankets, and towels.




# **AROUND THE RANCH ASPIRING ACTRESS LANDS ROLE IN WEST SIDE STORY**

# LWR "Handcrafts and More" Club Let's Go Meet, Craft, and Eat!

Recently I, a guy of a "certain age," walked into the first June meeting of the Lakewood Ranch Handcrafts and More Club – which meets at the Town Hall on the first and third Monday of each month, from 10 a.m. until noon – and found myself the recipient of a most warm welcome from the women at the meeting

The reason for my warm welcome was the fact that my late wife, Linda, had been a very active member of the Handcrafts and More Club almost from the time we moved to Lakewood Ranch until her death a couple of years ago. She loved the Club, and almost nothing would stop her from attending their meetings, unless she was dealing with medical issues or visiting our kids and their families out of town. For a long time, she was the Club's "contact person" for anyone thinking of joining.

Several of the women in attendance at the meeting I attended had known Linda, and remembered many interesting tidbits that she had shared with her Handcrafts friends over the years, including a few comments about some of my adventures. But, in that sharing of stories lies one of the main attributes of the Handcrafts and More Club.

These folks get together twice a month and bring whatever project they are currently working on, be it a needlepoint canvas they may be stitching, or a quilt for which they are making sections out of small bits of cloth, or perhaps a large, complicated counted-cross-stitch picture on which they are working.

They sit around several tables placed so that the members can look at each other over their projects, and they converse perhaps about the efforts they are making to complete the canvas, or maybe about their families or grandchildren, or whatever is going on in their lives at that time.

One of the women commented to me that this camaraderie, this sharing of ideas and slices of their lives as they work on their projects, had been one of the primary reasons why she had decided to make the move to Lakewood Ranch, and she still feels that way about the Handcrafts and More Club.

Karen Marinoff, who on the day I visited was crocheting a doll dress, admitted that she had joined the Club years ago after being encouraged by her husband, who had seen a note in the paper about the club, but had quit for a time to take a part-time job. When the company she worked for closed up shop, she came back to the Club, and considered



leaving to again work part-time, but quit after one day. She realized that she loved Handcrafts and More ... more than the job.

As for Karen's doll dresses, have you ever seen "Antebellum Barbie" dressed in a flower- bedecked pink dress?

After seeing these women communicating and exchanging ideas, I need not wonder why the group has been active in Lakewood Ranch since 2002, when the Handcrafts and More Club began its life at the old Lakewood Ranch Information Center building, in Summerfield Village, just south of State Road 70 on Lakewood Ranch Boulevard, before outgrowing that space and moving to the then-new Town Hall.

The projects that were being worked on at the early June meeting covered a variety of pursuits. One lady was actually working on a needlepoint canvas that had been originally purchased by my wife, but on which she had never worked. Another lady was cutting pieces of paper to use as backing for sections of a quilt. A couple of the other ladies were also working on quilt projects –although they were quite different from one another. Two of the women were working on counted-cross-stitch canvas; one with an ancient Egyptian theme, and the other a Jim Shore Christmas item, featuring Santa Claus. After all, Christmas is only six months away, and





these projects take time to complete!

By this time, the clock was moving toward the noon hour which, if you're a member of the Handcrafts and More Club, means that it was time to put away the projects and make the big decision as to where to go for lunch, since lunch is the item that caps off every meeting.

The conversations would continue over food, which is as it should be.

# **Cinci "Pilgrimage" Location Comes to The Ranch**

**t**'s a Cincinnati thing." At least that's what two different sets of diners told me when I asked them about Skyline Chili, as I ventured forth to test the spicy waters of chilidom in one of Lakewood Ranch's newer culinary emporiums - Skyline Chili, located on the west side of Lakewood Ranch Boulevard, between State Road 70 and State Road 64, just north of 44th Ave. E.

Feeling about a "pint low" after donating blood earlier in the day, and having missed lunch, I walked into Skyline Chili hungry – make that very hungry.

I was greeted by a smiling, cheerful employee who welcomed me to Skyline and asked if I knew what I'd like to order. I replied that this was my first time at Skyline, and I was unfamiliar with the offerings of the place, so he provided me with a menu that featured salads, Coney dogs, wraps, chicken, and "Ways" ... the "Ways" being the several different ways a diner could order his or her Skyline chili.

Sensing my hesitancy to pick an item I'd never tried, my waiter offered to provide me with a sample portion of Skyline's basic 'Three Way" chili (spaghetti pasta, chili, and cheese), and I was soon enjoying it.

Since I found this "basic" offering rather tasty - remember, I was QUITE hungry – I ordered a "small" plate of the "Three-Way" chili.

A few moments later, I was presented with a nice-sized oval dish, on which was a generous supply of chili-laden spaghetti,



topped with a GIANT mound of shredded cheddar cheese, with the added bonus of oyster crackers. These folks definitely did not skimp on the cheese! (And this was the "small" plate!)

The secret to Skyline's chili comes from the founder's recipe which incorporates finely ground beef, seasoned with cinnamon, allspice, cumin, nutmeg, and chili powder. The result is spicy, but not overwhelming.

I powered through this combination, feeling totally filled by the time I finished off my plate, and found that, unusual for me, I had no further appetite for dessert!

As for the other "Ways" offered by Skyline, "Four Way" involves the same basic spaghetti, chili, and cheese of the Three-Way, with the added feature of either onions or beans. "Five-

Way" comes with BOTH onions and beans, and the diner can also choose to have just the spaghetti and chili with none of the other items.

So, how did all this Cincinnati chili thing get started in the first place?

Well, according the the information proudly printed on Skyline Chili's menu, the restaurant was started back in 1949 by a Greek immigrant, Nicholas Lambrinides, who settled in - you guessed it - Cincinnati, eventually opening his restaurant "overlooking the skyline of Cincinnati."

Thus, Skyline Chili was born, and it quickly became a Cincinnati culinary staple, becoming a unique gastronomical treasure for the residents of southern Ohio and northern Kentucky.

As for the folks who gave me the answer of "It's a Cincinnati thing," when I asked them why they had come to Skyline Chili that afternoon, one couple, who had moved here from Cincinnati and had lived in the Lakewood Ranch area for some time, were obviously very happy that Skyline had come to town.

The other folks - two older ladies from - yes - Cincinnati, gave me the idea that this, to them, was much more than just a trip out to lunch. I was rather surprised that one of these ladies not only had a platter of Skyline Chili in front of her, but also a plate loaded up with TWO Coney dogs - also covered in chili and cheese! I could never have eaten all that but then, I did see a small boy come in to Skyline with them.

Skyline Chili has expanded over the years, and now has lo-





# Lakewood Ranch's Shred Day Has Shared Benefits

Lakewood Ranch's annual Shred Day has been a much looked-forward-to event in our community for several years now. The friendly folks at the Town Hall have partnered with Grow Financial Credit Union to offer a unique service to the community.

One particular Saturday morning each year – scheduled to happen just after "tax time" – a large document shredder truck pulls up to the Town Hall parking lot, and staffers from both the Town Hall and Grow Financial line up to take residents' boxes of old documents, old tax returns, old medical records, etc., out of their vehicles, and toss them into the bins provided.

The bins are hooked up to a conveyor belt that takes them up to the upper part of the truck, where the contents are dumped into a heavy-duty shredding machine inside the truck body, and......BZZZZZT, those old documents are turned into instant confetti.

Residents don't even have to get out of their vehicles – the workers take their boxes, toss the documents into the bins, and put the boxes right back into their vehicles, at which point the drivers can simply drive off.

By making use of Shred Day, residents don't have to worry that their important records might be retrieved from their trash by unscrupulous individuals. Those documents are shredded on-site and will never be seen in their entirety again!

This year's Shred Day also offered a chance for residents to feed the hungry in our area, as several volunteers from The Food Bank of Manatee were on hand to accept donations of non-perishable food items. One of the volunteers commented that, by 10 a.m., they had already collected several barrels of food, meaning that Lakewood Ranchers are heeding their call to donate food for the hungry.

# **Spring Fine Art Festival Draws Crowds**

Lakewood Ranch's Spring Fine Art Festival, held at LWR Main Street, became a pedestrian passage for those out for a nice stroll in the warm but not-yet-too-muggy weather.

The Spring Fine Art Festival is a juried art fair, an event where pre-screened artists can display their creations to the public in a casual setting, minus some of the more "crafty" or gimmicky art found in some art fairs. The artists here are serious practitioners, and the quality of the offerings found on Main Street was quite good.

The selections ranged from large installations – the type that would presumably take up a large portion of a home or office wall – to smaller, more intimate pieces, which could be used to uplift a small corner with color. There were also several jewelry makers who brought some of their works to the Festival. One jewelry artist made her items from sheets of soft acrylic, formed into intricate pieces, which were later painted in colors reminiscent of "carnival glass."

A broad range of media was to be found at the Spring Art Festival. Copper wall sculptures could be found, most of which had a coastal theme, along with hammered and painted figures – one notable was the large mermaid holding a bunch of flowers. One artist created various animals out of driftwood; imagine a great blue heron's head emerging from a large branch, or the tentacles of a large octopus coming out of a gnarled hunk of wood. There were a number of artists who had done their work using glass, from sculpted glass or decorative glass set into metal assemblies, to large works made by the "Glass Sisters," using glass tiles



to create stunning pictures. One artist had made various sculptures using old red wine barrels, utilizing both the oak staves and the metal bands that once held the barrels together.

Imagination runs wild in the minds of these artists. One guy had designed three-dimensional assemblies depicting various sports stadiums, with the "fields" lit up from within. Another had fashioned fanciful depictions of the favorite watering holes to be found in various big cities and college towns.

One of the major themes of the event appeared to be paintings of bird life, and landscapes. One particular artist, Janet Herman, created textile pictures of these birds and landscapes, using cloth and stitching to evoke the image.

Not much beats beautiful art in a beautiful place, framed by perfect weather.









# Family Night Highlights Community Involvement, Preparedness

The Knights of Columbus of Council #13341, which meets at our Lady of the Angels Church on State Road 70, held a Family Night Social at the Church Center in order to not only showcase the charitable efforts of the Council over the last year, but also to give local residents a chance to hear about the best steps to take to prepare for a possible hurricane.

The meeting gave neighbors the opportunity to learn about just a few of the agencies and organizations that receive not only support, but in many cases, manpower in order to assist in helping others, from the Knights.

For a number of years, the Knights have delivered the food donated by Church parishioners to St. Joseph's Food Pantry, located on Bradenton's west side. The St. Joe's pantry is one of the largest in the County and has been serving people since 1977. During the last quarter of 2018, the St. Joe's Food Pantry served over 5000 people; this number represents 14,000 family members in need in Manatee County, a volunteer said.

Their ability to serve the hungry is aided by monetary donations from business and individuals, donations of food from supermarket chains, as well as food donations from other folks, such as that donated by the parishioners of Our Lady of the Angels. The Pantry also buys food from grocery chains at a large discount.

The Pantry operates five days a week, except on holidays, and has a staff of 120 full time volunteers. They keep computer records of their clients, noting how many people there are in a family who need food, and clients are given a "membership card" to the Pantry.

The summer months are busier, as there is a drop in the number of volunteers when snowbirds go north for the summer, and there is also lack of school lunches during the break.

The St. Joe's Pantry also brings food to the homeless population; certain volunteers get to know where the homeless can be found, and food delivered to them in a non-threatening manner.

The next speaker was Christine Wyckoff, admissions director and Spanish teacher at St. Mary's Academy, which is also a recipient of donations from Knights of Columbus Council #13341, who presented Wyckoff with a check for the Academy at the Social.

St Mary's Academy is a Catholic school for special needs children, established to make sure that these kids reach their fullest potential. St. Mary's Academy has become the first school in the Diocese of Venice, in Florida, to achieve STREAM accreditation (science, technology, religion, engineering, arts, and math). St. Mary's Academy is currently the only exceptional student education (ESE) certified school with this accreditation in the State of Florida.

The Special Olympics program is nationally supported by the Knights of Columbus, and a check from Council #13341 was presented to Jim Baar, of Manatee Special Olympics. Baar brought with him one of the athletes who participate in the program; Joey is a pretty good tennis player, who commented that

Special Olympics "keeps me fit and helps me meet new friends."

Every year, the Knights of Council #13341 participate in raising funds for Special Olympics at the Hunsader Farms Pumpkin Festival, which is one of the biggest pre-Halloween traditions in Manatee County. Organizations such as St. Mary's Academy and Special Olympics are also partially funded through the annual Knights of Columbus "Tootsie Roll Drive."

For the last portion of the program, the Knights called on Mark and Kay Marcus, of the Lakewood Ranch Community Emergency Response Team (CERT).

Kay Marcus, as the prime presenter, went through a series of questions that residents need to answer well ahead of a possible hurricane hit. Marcus said that she moved to Lakewood Ranch during the period when Hurricane Sandy was devastating the upper Mid Atlantic region. She decided to get involved with CERT and after 20 hours of training, got certified.

She noted that, in 1993, FEMA started training volunteers to assist in emergencies, and there are now 600,000 CERT-trained members across the country. Locally, the Manatee County Emergency Management office is responsible for preparing for a disaster and training volunteers. Currently, Lakewood Ranch CERT operates in the "Phase 1" area of Lakewood Ranch: community development districts 1, 2, 4, 5, and 6.

Marcus noted that hurricanes are famous for being totally unpredictable – they can follow the path that meteorologists expect they will follow – or not. As a result, the best thing residents can do is to be prepared. The key thing is to decide, way before a hurricane nears Florida, is whether to leave or stay. And if you stay, will you be able to shelter in your own home, or will you need to go to a shelter? And, if you go to a shelter, will the shelter accept your pets? If they do, you'll need a carrier or crate for the pet, along with the pet's meds, food, leash water bowl, shot record, etc.

Lack of availability of hospital services during a major storm can be a problem, Marcus said. The services may be totally unavailable, as the hospital may be full of nursing home patients who were moved to the hospital; also, emergency room personnel may not be able to get to the hospital to perform their usual functions.

Communication is likely to break down, Marcus said, and normal police and fire services may not be functioning until well after the storm, as many jurisdictions will restrict the movement of their personnel and vehicles in order to protect their staff and equipment until it is safe for them to operate.

If you decide that leaving town is your best alternative, you need to leave early. There will be a lot of people from counties north of Manatee who will have the same idea – hit I-75 and drive North – and if you do go north, make sure that if you make a hotel reservation the hotel is not in the path of the storm, otherwise you may get there and find that there are no employees on duty, because they too, decided to "get outta Dodge."

Whether you go or stay make sure that you have with you important items, such as your medication(s), medical history, marriage certificate, divorce decree, Social Security documents, insurance policies – including your flood insurance policy if you carry flood insurance – the deed to your home and, noted Marcus, go around your home and take pictures of everything, so that if you need to file an insurance claim you have proof that the items lost or damaged in the storm were there prior to the storm. Also plan on taking some food, water, clothing, and other items with you – like flashlights and batteries – even if you do leave early. Make sure that you go to the store and purchase any needed items now …before the shelves are bare at Publix or Home Depot.

If you leave, also take copies of utility bills or tax bills, in order to prove that you are actually a resident of Lakewood Ranch, since there may be a curfew in place, and law enforcement may not allow you to return to your home if you can't prove that you are the resident. Marcus advises that if you leave, try to go at least five days before a storm is expected to arrive.

One last comment from Marcus – cash is king. Your credit and debit cards may be useless if businesses have no power. Take a good supply of cash, including lots of small bills to pay for small items you may need on your journey. Handing a convenience store clerk a big bill for a snack or bottle of water may not work if his cash register is locked up from a lack of power.

After all the presentations were completed, the Knights served their neighbors a staple of their meetings – food!
