## New Law Changes Mean Easier Time for Homeowners

During the Lakewood Ranch Community Development District board meetings held at the Town Hall in July, it was announced by the various board attorneys that a rule change was recently passed by the Florida Legislature that will make it easier for homeowners to remove dead or diseased trees from their property.

Under the old regulations homeowners who had a dead tree, a tree which posed a hazard to a structure, or a diseased tree on their property, and who wanted to remove the tree, were required to get permission from the county to do so.

Under the terms of the revised statute, in Chapter 163 of the Florida Code, if the property owner obtains a determination by a landscape architect or a certified arborist that the tree should be taken down, the property owner may remove the tree, and is not required to replace it.

The local government is no longer required to approve the move if the property owner follows the new guidelines.

#### **"TOO BIG" PALMS**

District 2 Board Chairman Pete Bokach raised the issue at his district's board meeting about the size of many of the district's Washingtonian palms, such as the very tall palms at the Legacy entrance area. He noted that many of these older palms are getting very tall, making them so high that it will soon be difficult or impossible to trim. Bokach suggested that the Country Club districts start to formulate a plan in the very near future for the removal and replacement of these trees.

#### **BUDGET APPROVAL**

The fiscal year 2020 Lakewood Ranch CDD budgets will be given their final approval at the various CDD board meetings held at the end of August.

#### **SAFETY TOWN**

Supervisor Laura Fox of District 1 reported that the plans for the "Safety Town" event, which will be held in October, are well under way.

The event will involve the Manatee County Sheriff's Office, and the Manatee County Health Department – which will be bringing their "germ box" to teach kids about how to avoid germs and bacteria. There will also be folks on hand to teach kids about safety in the water.

#### PAVING, EROSION AND WATER QUALITY ISSUES

During the District 2 CDD board meeting, Finance Director Steve Zielinski reported that the district was running quite close to its budgeted limit for this fiscal year. The expenditures that are driving the costs involve a major paving project, in addition to spending on plant replacement. The cost of the paving project alone, per Board Chairman Bokach, is currently around \$900,000.

Engineer Richard Ellis also commented that due to the recently heavy and frequent rainfall, paving issues are being highlighted by water puddling on area roadways.

Erosion is becoming an issue in both districts 2 and 5. In District 2, the Dewberry Engineering firm did a survey that highlighted extensive erosion at Augusta Pond # L241. The work to repair this problem will be done during the next fiscal year.

In District 5, an issue has come to note regarding rainwater runoff from a berm in the Presidio/Riviera area. Per Ellis, there is nothing to catch the runoff from the berm, and the pipe system in the area does not properly drain.


One homeowner has reported that the water level outside his home gets higher than his lanai, and also that water has gotten under the lanai pavement, and is damaging that area. Residents are encouraged to forward their questions regarding this issue to supervisor Dave Emison, rather than calling Town Hall or the operations department, so that he can narrow the questions down to a smaller list that can then be answered in a more efficient manner.

There have been concerns raised recently about the water quality in Lake Uihlein. District 2 supervisor Mike Finney reported that samples have been taken from the lake that show a "dissolved solids" reading of 495 ppm. The "safe" limit is 500 ppm, so the samples show levels very close to the limit. The University of Florida is involved, and will be sending a report, but they have also asked for more data. It is hoped that the University's final report will contain suggestions as to how to deal with this issue. The report is expected prior to the August CDD board meetings.







# Keke's Breakfast Café has Settled in on The Ranch

For months, Lakewood Ranchers anticipated the opening of the new Keke's Breakfast Café in the still-growing shopping center known as The Green, at the corner of Lakewood Ranch Boulevard and State Road 70.

Keke's Breakfast Café is a well-established chain of breakfastand-lunch restaurants with multiple locations around Florida, from Fort Lauderdale to Tallahassee. Probably the location most familiar to Ranch residents is the one in the University Town Center complex, located on the north side of University Parkway, west of I-75.

Keke's website proclaims: "It's like your hometown diner grew up and went to the city." Well, I don't know what "going to the city" means, but I went to the new Keke's a couple of weeks after they opened up their Lakewood Ranch restaurant, along with a friend who has accompanied me on a number of these restaurant check-out excursions.

Since we arrived shortly after noon, partly to avoid the "lunch rush," we ordered lunch. My guest ordered a turkey burger with lettuce, mayo, potato chips, and a pickle. Our waiter, Brendon, accommodated her when she asked for a "regular bun" instead of a ciabatta bun.

After finishing her burger Edna proclaimed that it was pretty tasty, noting that in a lot of restaurants turkey burgers, in her experience, tended to be rather bland and tasteless. This one has some spices added to the mix, and she enjoyed that.

The only other comment she made regarding her sandwich was that she felt that it was a bit of a waste to put lettuce on a hot sandwich, stating that the lettuce was wilted when Brendon brought it to the table.

I, on the other hand, chose the Southwest turkey panini, which came with the usual potato chips and a pickle spear. This sandwich is described in Keke's menu as being made with turkey breast, tomato slices, pepper jack cheese and something called "Texas petal sauce."

Now, you would think that a "Southwest" sandwich would have a little spicy "bite" to it, but this one, while reasonably tasty, was pretty bland, with absolutely no "spicy" aspect that I could discern. The "turkey breast" portion of the sandwich was of the deli sliced lunchmeat variety, rather than something carved from a bird.

That said, the sandwich was good-sized and as I'd had a late breakfast, I found myself asking Brendon for a box to take half of it home, to be consumed the next day for lunch. When I heated it up it still tasted good. (Note: I discussed the rather bland aspect of my "Southwest" sandwich later on with Gabe, the manager, who seemed surprised, and thought that maybe someone in the kitchen had forgotten to put on the "Texas petal sauce," which was supposed to provide the spicy taste.)

I returned to Keke's a couple of days later, for breakfast this time, and ordered a Western omelet, which was very good – about as good as I've gotten locally, with a definite "fresh" taste. My impression is that Keke's forte lies in their breakfast offerings. Here again, the service by my waitress, Cindy, was attentive and cheerful.

I found out that several friends had recently dined at Keke's



new location, and from them I got generally favorable comments on their breakfast choices, including the "Hawaiian omelet." Keke's bacon, cheese and jalapeno burger got a rave review! One guy, however noted that he was a little taken aback at the cost of his customary ham–and-cheese omelet at Keke's. He told me that the omelet and a cup of coffee left him with a bill for over \$13 (\$12+ change without tax or tip), and that he'd had the same item at another nearby local chain restaurant for just over seven bucks just a day or two earlier. (Note: Keke's does not offer meal "specials," unlike many other local restaurants.)

The ambiance/décor at the new Keke's Breakfast Café is similar to the older location, although the southern exposure at the new Ranch location means that there's a lot of light streaming into the large windows on the front of the building. The booths are comfortable, and I didn't feel like I'd been placed in a too-narrow seat. The floor tile has a "slate" look to it, the walls are decorated with large pictures of fruits and vegetables, from strawberries, to blueberries, to tomatoes, asparagus, etc. The interior is accented with copper-toned lights above the tables, which produce a diffused, reflected light. If you look up, you aren't going to be staring into the filament. All in all, Keke's Breakfast Café in Lakewood Ranch is a pretty inviting place to eat.

As my dining companion at lunch was wearing a surgical "boot," the staff was kind enough to get us a table right near the front door of the restaurant, so she would not have to "hoof it" to the back of the place, a gesture that I'm sure she appreciated.

Keke's gets a good mark from me regarding how clean the place is. OK, even given that the restaurant was only into its third week when I dined there, there did seem to be a push toward maintaining a high level of cleanliness. On leaving to go to my car, I witnessed a couple of Keke's staff members walking outside to shake the outdoor mat at the entrance to the restaurant, in order to get rid of the accumulated dust and sand from





the surrounding construction projects, so that it would not be tracked into the restaurant.

So, there you have it. Keke's Breakfast Café is open for business in The Green shopping center, at State Road 70 and Lakewood Ranch Boulevard. As the name implies, they do a great breakfast – or you could go for lunch.

Keke's Breakfast Café is open daily from 7 a.m. to 2:30 p.m. every day except Thanksgiving and Christmas. For more information visit kekes.com.

## Lakewood Ranch Medical Center Receives Two Quality Awards

Lakewood Ranch Medical Center (LWRMC) has received two quality awards, recognizing its commitment to quality care for those who suffer two major health events.

The hospital received the Mission: Lifeline Gold Receiving Quality Achievement Award for implementing specific quality improvement measures outlined by the American Heart Association for the treatment of patients who suffer severe heart attacks.

Every year, more than 250,000 people experience an ST elevation myocardial infarction (STEMI), the deadliest type of heart attack, caused by a blockage of blood flow to the heart that requires timely treatment. To prevent death, it's critical to restore blood flow as quickly as possible, either by mechanically opening the blocked vessel or by providing clot-busting medication.

The American Heart Association's Mission: Lifeline program's goal is to reduce system barriers to prompt treatment for heart attacks, beginning with the 9-1-1 call, to EMS transport and continuing through hospital treatment and discharge. The initiative provides tools, training and other resources to support heart attack care following protocols from the most recent evidence-based treatment guidelines.

LWRMC earned the award by meeting specific criteria and standards of performance for quick and appropriate treatment through emergency procedures to re-establish blood flow to

blocked arteries in heart attack patients coming into the hospital directly or by transfer from another facility.

Lyn Swann, director cardiovascular services for LWRMC, said the hospital is dedicated to providing optimal care for heart attack patients, and is pleased to be recognized for dedication to, and achievements in cardiac care through Mission: Lifeline.

"We commend LWRMC for this award in recognition for following evidence-based guidelines for timely heart attack treatment," said Tim Henry, MD, Chair of the Mission: Lifeline Acute Coronary Syndrome Subcommittee. "We applaud the significant institutional commitment to their critical role in the system of care for quickly and appropriately treating heart attack patients."

The hospital has also received the American Heart Association/American Stroke Association's Get With The Guidelines Target: Stroke Honor Roll Elite Gold Plus Quality Achievement Award. The award recognizes LWRMC's commitment to ensuring stroke patients receive the most appropriate treatment according to nationally recognized, research-based guidelines based on the latest scientific evidence.

LWRMC earned the award by meeting specific quality achievement measures for the diagnosis and treatment of stroke patients at a set level for a designated period. These measures include evaluation of the proper use of medications and other stroke treatments aligned with the most up-to-date, evidence-based guidelines with the goal of speeding recovery and reducing death and disability for stroke patients. Before discharge, patients should also receive education on managing their health, schedule a follow-up visit, as well as other care transition interventions.

## Peace, Love, and Yoga in Lakewood Ranch

Do you remember the '60s? The 1960s, that is.

The Beatles became the opening salvo of the "British Invasion" in pop music. Woodstock brought a whole new meaning to the term "music festival." But there was something else that came about during the '60s which, in some ways, is still with us.

Perhaps the Beatles were part of another emerging addition to American culture – one that had previously been pretty much non-existent, and that addition was a new awareness of Indian culture.

Prior to this period, Americans knew very little about the culture of India. What little they did know came largely from magazines, old Hollywood movies and newsreels of goings-on in the old British colonial period-pictures and articles about the Taj Mahal in National Geographic, etc.

The popularity of the Beatles in America, and their foray into Indian culture, mysticism, and music during that period, brought Americans a new awareness of things Indian. The Beatles' George Harrison got together with Indian sitarist Ravi Shankar, and this collaboration brought a whole new "sound" into American pop musical culture. Suddenly, things Indian became "cool," and this new influence even extended to American fashion. Remember Nehru jackets?

Also, during this period, more and more Indian people were coming to the U.S. for educational opportunities, and many stayed to work and live in America, bringing their traditions in food, culture, etc.

One of the things that has come out of the emergence of Indian culture in America is the practice of yoga, and here in Lakewood Ranch, we have an opportunity to enjoy the benefits of this exercise/spirituality/art form by joining in the activities of the Shanti Yoga Club, which meets at 10 a.m. Fridays at the Lakewood Ranch Town Hall.

Lilly Chaddha is the Yogini (instructor) of the Shanti Yoga Club, and Lilly describes yoga as "peaceful exercise"; "shanti" means "peace."

Chaddha learned to become a yogini at the Yog Sadhan Ashram in Chicago, and has been a yoga instructor for 15 years, promising her teacher that she would keep the practice alive by teaching others. After moving to Lakewood Ranch five years ago, she began searching for a suitable place to instruct locally in the art of yoga. The Lakewood Ranch Town Hall was found to be the ideal setting for Shanti Yoga.

Shanti Yoga members enter the designated salon area at



the Town hall after removing their shoes. This is an indication that the yoga meeting room is a place of sanctuary. Chaddha refers to it as "a holy place for me."

The yoga routine is then begun by Chaddha, and involves a number of movements that have different aims, such as the rubbing of the hands together, a movement that creates warmth.

Chaddha draws her students through an entire hour's worth of movements, some of which involve stretching action, shoulder rotation, hand exercises, wrist rotation, leg massage, and so on. There are deep breathing moves, and movements during which the participant will close off one nostril and breathe through only the opposite nostril. These breathing exercises are known as "Pranayama."

Note that all of these movements are done in slow motion. Nothing is done in a jerking fashion; there are no sudden movements. The idea is to stretch every part of one's body, and includes movements intended to massage the body's internal organs so that they function better.

In her own life, Chaddha uses yoga as a preparation for meditation, so that she achieves a feeling of peace and relaxation in order to concentrate on her meditation.

The Shanti Yoga Club is indeed a sanctuary for its members, and they love the feeling of relaxation that the yoga exercises give them. Lee Frank, a three-year resident of Country Club West, has been attending Shanti Yoga sessions for two



years and says that it gives her a good way to stretch and relax.

So, if you'd like to learn yoga, if you'd like to s\_t\_r\_e\_t\_c\_h out those muscles and feel better for having done so, come on down to the Shanti Yoga Club at 10 a.m. Fridays at the Lakewood Ranch Town Hall.

There is no charge for attending the sessions, although a donation toward insurance expenses is appreciated.

Come on down and meet Lilly Chaddha. Participate in a Shanti Yoga session and gain an appreciation for this unique gift of Indian culture. For more information email chadsugar@ aol.com.

## Brain Health Initiative Secures \$1.4 Million in Funding to Advance

Companies, organizations and individuals from throughout the Gulf Coast region have provided the funding for the next phase of the Brain Health Initiative (BHI). Encouraged by the \$1.4M raised since the initiative's launch in March of 2019, the green light has been given to move forward with Phase 2 of the initial three phase project. Phase 2 includes developing a brain health community impact model that can be measured and replicated throughout the Gulf Coast region, planning for a longitudinal brain health pilot study and developing the infrastructure for a BHI Lab in Lakewood Ranch.

"Discovering the basis of brain health may be the most important medical challenge of our time," said neuropsychologist Stephanie Peabody, Psy.D., HSPP, who serves as the founder and executive director of the BHI. "We've been overwhelmed with support from Lakewood Ranch and the greater Gulf Coast community, as well as throughout the state of Florida and nationally. We are thrilled to begin the next stage in this landmark, multi-generational initiative."

The fundraising effort began in March with a \$600,000 donation by Schroeder-Manatee Ranch, developer of Lakewood Ranch. Since then, the BHI has received strong support from leadership throughout the greater Gulf Coast region (and across multiple sectors), including individual philanthropists, area businesses, major corporations and community foundations. Additional fundraising efforts are ongoing to support mediumand long-term goals for the project.

The BHI was formed by The Academy for Brain Health and Performance (ABHP) in collaboration with Massachusetts General Hospital (MGH), a Harvard Medical School teaching hospital. This large-scale effort is designed to uncover the factors, both positive and negative, that affect brain health and performance, as well as discern, develop and test interventions aimed at optimizing brain health throughout the lifespan.

"This milestone plants a life science flag on the west coast of Florida and creates opportunities for our region to lead the state and nation in increasing brain health outcomes," said Garrett Shinn, president of Lakewood Ranch Community Fund (LWRCF), which is one of the donors. The LWRCF, which was established in 2000 to enhance the quality of life in and around Lakewood Ranch, has created a separate fund to facilitate donations to the BHI.

The board of advisors has approved a grant of \$15,000 per phase, for a total grant of \$45,000, to the new fund, the "Lakewood Ranch Community Fund Brain Health Initiative." In addition to the grant approved by the board, the new fund already has facilitated more than \$120,000 in donations from supporters throughout the region.

Planning for the pilot study (Phase 2) will begin this Sep-

tember. Over eight months, the team will build from insights gained during the initial Phase 1 surveys that were conducted last year with more than 500 Lakewood Ranch residents. Throughout Phase 2, researchers will conduct focus groups across the region and use the findings to create strategies for the pilot study, as well as receive input from additional scientific leaders and develop the brain health baseline survey to be implemented in Phase 3.

Launch of the Pilot Study (Phase 3) will begin in spring of 2020. In addition to implementing the pilot study, the team will begin developing early plans to facilitate clinical trials and unveil plans for the BHI lab. Located in Lakewood Ranch's 305-acre CORE (Collaboration Opportunities for Research and Exploration) campus, the lab will serve as a space where global innovators, entrepreneurs and investors can come together to validate brain health solutions and evaluate innovations for commercialization purposes.

The BHI lab will bring brain health science and solutions to where Gulf Coast residents live, work, learn and play. For example, brain healthy schools, workplaces, grocery stores and restaurants will be developed. Schools and businesses can be supported across a variety of brain health protective factors that contribute to enhanced brain health and optimal brain perfor-

mance across a person's lifespan. Grocery stores and restaurants can be enhanced to offer brain healthy shopping lists and menu selections to their customers.

An estimated one in three people worldwide suffers from a brain-related health condition, according to Erin Dunn, Sc.D., an epidemiologist and professor of psychology at MGH, and assistant professor of psychology at Harvard Medical School.

Dunn, who is the director of research and a principal investigator for the BHI, added that the goal of the initiative is to research issues affecting brain health to develop new methods of diagnosing and treating a range of neurological and psychiatric conditions across the lifespan from Alzheimer's and Parkinson's disease, to autism, addiction disorders, depression and anxiety, all while working toward lessening the prevalence and burden of brain-health conditions in the long run.

"I am hopeful that this initiative will lower health care costs and improve quality of life by helping promote brain health and reducing brain-related diseases," said U.S. Representative Vern Buchanan, a senior member of the House Ways & Means Committee, which has jurisdiction over tax policy, international trade, health care, welfare and Social Security.

The BHI is inspired, in part, by the long-term, ongoing Framingham Heart Study. Commissioned in 1948 by the National Heart, Lung, and Blood Institute and Boston University, the study is widely credited with uncovering the effects of smoking on the heart, benefits of aspirin and a healthy diet, and the relationships between high cholesterol and heart attacks.
