District 4 to Determine Pavilion Replacement Parameters

Dark the supervisors of Lakewood Ranch Community Development District (CDD) 4 decided to continue their meeting by a week to determine exactly what the priorities were for the reconstruction of the Greenbrook Adventure Park pavilion. The structure burned down on the evening of July 4, 2023 due to a fire that was ruled accidental.

Residents Nancy Roush and Penny Kress attended the meeting and asked if a polling opportunity could be made available to the residents regarding what the priorities should be for the design and construction of the new pavilion. One of their concerns had to do with whether the District needed to provide additional restroom facilities, considering the number of events held at the park, and the increasing number of visitors.

From the standpoint of the supervisors, time is not on the side of getting the work done as quickly as possible, and polling residents would take additional time. The Board, in continuing their meeting to the following week, made that continued portion of the meeting for the purpose of deciding just what the District needed to do, and what priorities would be important going forward. The Board needs to decide what features will be required, and just how to pay for the reconstruction. One thing is certain: The Board is looking to build a new pavilion using non-combustible materials.

One stumbling block to reconstruction is the fact that the District's insurance carrier, Florida Municipal Insurance Trust, is at this time only willing to pay out a small portion (less than half) of the replacement value that the facility was insured for. They claim that because the District had not increased coverage, somehow, by their calculations, it is therefore liable for a penalty, which reduces the payout.

Is this actually legal? Supervisor Nancy Johnson asked Attorney Andrew Cohen to check to see what new Florida laws are now in place that would allow this practice.

The pavilion was insured for a replacement value of \$200,000. It is roughly estimated that reconstruction of the pavilion could cost the district between \$400,000 and \$500,000, depending on what changes to the original plans are made.

The District 4 Board did approve the re-decking contract with Custom Deck and Davit for the renovation of the Adventure Park Bridge, at a cost of \$111,300. The material to be used is called "Wear Deck," and is a com-

posite, fiberglass-based wood-free material, which carries a lifetime warranty to the original buyer.

The Greenbrook HOA has adopted a new policy regarding home rentals. A homeowner must own their home for at least two years before leasing it.

Supervisor Nancy Johnson, reporting on the formation of the new Inter-District Authority (IDA) budget, said that the IDA is estimating a budget increase of 13.2% for the 2025 fiscal year. This will affect district budgets.

POTHOLES AND CELL SERVICE

At the District 1 board meeting, much attention was given to the condition of the pavement on Lakewood Ranch Boulevard in District 1, part of which currently has the appearance of "patches over patches over patches," a situation that has residents very concerned about dodging the potholes and rough areas. It has been proven that poor road conditions cost drivers money for repairs and replacement costs for their vehicles.

Manatee County has re-paved a couple of lanes of Lakewood Ranch north of State Road 70, but this does nothing to help those who must use the road south of State Road 70. The pavement on University Parkway is also not in great shape, and the same could be said for portions of Lorraine Road.

Part of the problem may be that the roads were not constructed to withstand some of the heavy usage that they have been exposed to. Since our area continues to experience a lot of growth, there are heavy trucks using the roads, which have a tendency to "beat up" roadways over time. Maybe the county needs to look at a more heavy-duty approach to the original road construction, in order to avoid having to re-pave them sooner rather than later.

Since it has been estimated that Lakewood Ranch contributes something like 30% of Manatee County's revenue, perhaps it's time for the County to realize that our community needs a bit more attention.

Another issue that District 1 supervisors are concerned about is that of poor cell phone service. Lakewood Ranch has, for at least 20 years, had challenging cell phone service. Several years ago, after doing a study on the issue, a company agreed to construct towers in Lakewood Ranch, but the larger cell carriers refused to get on board, citing the idea that they wanted to build their own towers. A few "short" cell towers have been constructed along Lakewood Ranch Boulevard, but as they are short, their reach is not optimal.

Gold Star Memorial Marker to be Dedicated in Lakewood Ranch

he Gardeners Out East club, together with Manatee Library Services and Veterans Services, will celebrate Gold Star Families with the dedication of a Gold Star memorial marker at 10 a.m. May 4, on the grounds of the Lakewood Ranch Library, 16410 Rangeland Parkway, Lakewood Ranch.

In May of 2015 the National Garden Clubs, with the approval of the Department of Veterans Affairs, developed a program devoted to loved ones who lost their lives in the service of the United States Armed Services. It is an adjunct program to the National Garden Clubs Blue Star marker, which is the program designated as a living tribute to men and women who served, are serving, and who will serve in the Armed Forces.

Gold Star Families, a 501(c)(3) not-for-profit organization, is dedicated to providing support to families who have lost a loved one in the service of the country. The mission of the Gold Star Families is to offer hope and healing through remembering fallen heroes and coming together for special events. They provide healing through emotional and psychological support to the families.

Representing the Gold Star Families for the Lakewood Ranch Library site is Stefenie Hernandez, whose 21-year-old son Patrick L. Lay II was killed in the line of duty in Afghanistan in 2011. He graduated from Braden River High School.

There are a total of 47 Gold Star markers in the United States, eight of which are located in Florida. This marker will be the ninth. It will join the Blue Star Memorial that was dedicated by Gardeners Out East of Lakewood Ranch at the Lakewood Ranch Town Hall in May 2017.

In order to get the County informed and involved in these issues, Manatee County Commissioner Ray Turner has been invited to visit the next Board meeting in April.

A resident from the Bluffs neighborhood came to the District 1 meeting to ask what could be done about people fishing in the pond in back of her home. She was concerned that these anglers could observe her lanai. The District board is looking into the possibility of perhaps putting some signs up in the area to deter fishing behind homes.

PAVEMENT MANAGEMENT SYSTEM

The Country Club roads, which approximate 47 miles of pavement, are open to the public, but owned and maintained by the CDDs in the Country Club environs – districts 2, 5, and 6.

There has been a lot of discussion at the districts' board meetings lately regarding the major increases in the cost of paving, especially with a large portion of those roads getting older and, as a result, becoming more deteriorated. Our Florida heat does do a job on pavement over time, as does rain, etc.

Paving costs have risen partially from inflation, and also because there are only a couple of major paving companies currently operating in our area, which makes for less competition.

It has been proposed to have an engineering firm evaluate those roads to determine their condition, and when they might need to be re-paved, AROUNDTHERANCH.COM

whether there are issues with items such as underdrains, sections that may be sinking, and so on.

The result is a proposal to hire the engineering firm of Kimley-Horn to do a pavement management study to lay out just what the priorities need to be regarding the Country Club roads. This study would then be used as a priority list blueprint going forward, in order to guide the districts as to where best to put their paving dollars. District 2 Board Chairman Pete Bokach noted that this sort of report would better enable the District to "do it right and do it well," in addition to providing a basis for checking into funding possibilities in the future.

The boards of District 2 and District 5 approved engaging Kimley-Horn to do the pavement management system study, which has been estimated to take as much as five months, since the company has a backlog of work.

However, the Board of District 6 unanimously turned down the idea, noting that they felt that this would not serve their needs all that well, since prior to doing a paving project, District 6's practice has been to have the area checked out just prior to doing the work, and they feel that this procedure gives them a better idea as to "real-world" costs at the time they enter into a contract with a paver, rather than to rely on a study done way ahead of time.

All districts signed off on their audit engagement letters with Purvis Gray and Company for their fiscal year 2024 audits. Agave Bandido Holds its Long-Anticipated Grand Opening



Fourth Degree Knights Celebrate Patriotism

In February, the Fourth Degree Knights of Columbus of San Damiano Assembly #3192 celebrated the Country and their dedication to patriotism at their annual patriotic/military ball held at Tara Golf and Country Club. Many of the attendees were there in their military dress uniforms, as well as several representatives from the New York City Fire Department.

The Knights of Columbus organization was founded in 1882 in New Haven, Conn., by a parish priest, Fr. Michael McGivney. Mc-Givney, like others of his generation, had grown up poor in a large northeastern industrial city.

Back then, there was no workman's comp to protect workers, and the biggest fear among the families of workers was that their breadwinner would be injured or killed in a work accident, and the family would be left with little or no income. This happened to McGivney, as after he had started his seminary studies, his father died, and he had to come back home to support his family. Fortunately, the local bishop managed to find funds to support McGivney's family so that he could return to his studies.

As a parish priest, McGivney founded the Knights of Columbus as a means of providing some security for the widows and orphans of those families.

The Knights organization grew quickly, and eventually became the largest Catholic men's fraternal organization in the world. Members of the Knights of Columbus have included men such as President John F. Kennedy, baseball great Babe Ruth, Bears' coach Mike Ditka, former Florida Governor Jeb Bush, Senator Joe Manchin, and Supreme Court Justice Samuel Alito.

In addition to their original values of charity, unity and fraternity, in 1900 the Knights added one more: patriotism, which became the Fourth Degree of the Knights. During World War I, the Knights set up "huts" near the front lines in Europe, where they passed out snacks, coffee, etc., to weary troops, and these huts were open to all soldiers. During World War II, the Knights established a million-dollar fund to support families who had lost a member to the war.

Fourth Degree Knights make it their business to honor veterans and first responders. In our area, they have made numerous trips to Veteran's Administration hospitals in Tampa and St. Petersburg, as part of the VAVS (Veterans Affairs Volunteer Services) program,





meeting and talking with hospitalized vets and giving them tokens of appreciation.

Local Fourth Degree Knights provide honor guards for funerals at the Sarasota National Cemetery, especially for veterans who may not have family or friends to attend their final honors. In addition, they have been active in building homes through Habitat for Humanity, and have contributed to other organizations that assist veterans, first responders, and their families. They do this through contributions to charities such as the Paws for Patriots program at Southeastern Guide Dogs, which provides service dogs for blinded, injured or PTSD-stricken veterans; and the Fisher House at Tampa's Haley Veterans Hospital, which houses the families of veterans getting medical care there, among others. The San Damiano Fourth Degree Knights also are a backbone of the Tidewell Hospice Honoring our Veterans program.

This year, the San Damiano Assembly's patriotic honoree was Pfc. Ezequiel Rodriguez-Guadalupe, a medically retired veteran of the 82nd Airborne Division, representing the Tunnel to Towers Foundation.

He had dreams of becoming a commercial pilot, but two weeks after Sept. 11, he enlisted in the Army. During a training jump, wind turbulence created a problem with his equipment and his parachute collapsed, causing him to drop from a dangerous height to the ground, injuring his spine. He continued to do additional jumps to attain his parachutist's badge, but the damage to his spine became worse, and he was honorably medically discharged. He went to the VA, where he was treated more for the pain than the underlying cause, and eventually found himself permanently in a wheelchair.

The Tunnel to Towers Foundation was founded after 9/11 to "do good." The name Tunnel to Towers comes from the heroism of New York firefighter Stephen Siller, who having finished his shift in Brooklyn, heard about a plane hitting the North Tower at the World Trade Center. He called his wife and told her that he was headed to the scene but could not drive through the Brooklyn-Battery Tunnel, as it had been closed to traffic. So, he took his gear and ran through the tunnel to the World Trade Center, where he gave his life in service to his community.

The Tunnel to Towers Foundation serves by providing mortgage-free homes to Gold Star and fallen first responder families with young children, and by building special "smart" homes for catastrophically injured veterans and first responders.

Pfc. Rodriguez-Guadalupe heard about Tunnel to Towers in 2019, but at that time the foundation was set up to help only veterans who were injured in combat military action. Later, that policy was changed to accept vets who had been injured in military training. Tunnel to Towers is building a "smart" home for Pfc. Rodriguez-Guadalupe, his wife, Sol, and their children. It will feature, among other amazing things, a stovetop that can be lowered so that he can cook, which was one of his favorite things to do pre-injury. The Fourth Degree Knights of San Damiano Assembly presented Pfc. Rodriguez-Guadalupe with a plaque and a check for \$3,000 for the Tunnel to Towers Foundation.

Surgical Treatment for Conditions of the Gallbladder

Removal of the gallbladder, or cholecystectomy, is one of the most common operations performed by a general surgeon. More than 1.2 million cholecystectomies are performed annually, according to the National Institutes of Health.

Cholecystectomy is most often recommended for patients with gallstones, but many patients have an abnormality of gallbladder function that also responds to the surgery, according to David Dexter, MD, of Lakewood Ranch Medical Group General Surgery. Dr. Dexter performs robotic laparoscopic cholecystectomies at Lakewood Ranch Medical Center.

The gallbladder is a pear-shaped organ that sits just below the liver on the upper right side of the abdomen. Its purpose is to collect and store bile, a digestive fluid made in the liver. "Most patients can live normally without their gallbladder," said Dr. Dexter. "Additional supplements or significant changes in diet after



cholecystectomy are not usually necessary."

SYMPTOMS OF GALLSTONES

Gallstones are salt crystals that form within the gallbladder. They are especially common in women, but nobody is immune, according to Dr. Dexter. Gallstones and gallbladder disease can cause a sense of bloating or mild discomfort in the upper abdomen after eating.

"The pain doesn't necessarily happen every time, but typically occurs after eating rich, fatty or greasy foods," said Dr. Dexter. "Many may mistake the pain for indigestion, upset stomach or reflux. Often, individuals self-treat with over-the-counter medications for years before seeing a doctor about their gallbladder. Patients should seek the advice of their healthcare provider. Recurrent discomfort after eating should never be considered normal.

"As gallbladder disease progresses over time the pain becomes more sharp or intense and can be associated with nausea and vomiting. At this point, patients usually present to the hospital ER for emergency treatment," added Dr. Dexter.

CHOLECYSTECTOMY OR GALLBLADDER REMOVAL


Dr. Dexter removes the gallbladder using a minimally invasive robotic approach. The operation requires only four small incisions, about ½-inch in size. Most patients are discharged home the same day.

"Patients should expect to have two to three days of moderate discomfort after the procedure, including shoulder, chest or back discomfort. It is not debilitating, but may keep one from working. Most of my patients are back to normal activities five to eight days after surgery," said Dr. Dexter. "The overwhelming majority of patients should expect to experience relief of their prior symptoms and can now eat foods previously eliminated from their diet."

Dr. Dexter added that every one of his cholecystectomy patients receives a thorough preoperative explanation of the procedure until they understand the surgery completely. He also helps them to navigate through any concerns postoperatively until they are back to their normal lives.

THE (PET) DOCTOR IS IN!

pril is here. We are trying to get in outdoor time while we can before the oppressive summer heat sets in. At the same time, we're getting more humidity, more rain, and more mosquitos. No wonder April is Nation-

al Heartworm Awareness Month.

Heartworms are injected into dogs and (not as commonly) cats when an infected mosquito bites them and takes a meal. The mosquito deposits heartworm larva (babies) directly into the pet's blood stream. Over the next few months, the larvae grow into adult worms that live in the heart and lungs, clogging blood flow and creating damage to those organs. Heartworm disease typically goes unnoticed until significant damage has been done. At that point, there is often coughing and exercise intolerance. Left untreated, heartworm disease can be fatal.

The good news is that, given proper preventative control, heartworm disease can almost always be avoided. "Back in the day," heartworm prevention involved giving daily medication and even missing one dose would increase the risk of disease. Luckily, science

and technology has come a long way in helping our furry friends (especially those of us who sometimes forget all of our daily tasks). There are now multiple monthly chewable heartworm preventions that many animals will eat as a treat. Have a picky pet with a discerning palate? No worries, there are also monthly topical preventatives that you can apply at home. Have too much going on in life? There is also a yearly injection for heartworm prevention in dogs.

Heartworm disease can be devastating. Treatment for heartworm disease can be very harsh on the pet. Thankfully we have come a long way in being able to help our pets live healthy lives by preventing disease, rather than waiting until it is too late. If your pet is on heartworm prevention, good job and keep it up! If it is not, talk with your vet about which prevention is right for you and your pet.

So as flowers bloom and the beach (for Floridians) starts to look more appealing, we begin to let our red wines rest in our wine racks and choose something lighter and more suited for the sunshine. What better way to lounge in a beach chair and watch the surf go in and out than having a delicious and light chardonnay at your side?

I'm Vigo, The Unassuming Wine Bro (UWB) – a regular guy who loves everything about wine, including writing about it. I aim to explore the nuances of wine, share my adventures with you, and have a little fun along the way.

At the beginning of the year, I told you my goal is to highlight domestic wines. There has been a 20% downturn in domestic wine consumption in the U.S. since last year. Because of this, many wineries are struggling to survive. So drinking domestically is like chanting "U.S.A." every time you take a sip. As this month's star is chardonnay, we will visit California, the king of chardonnay in the U.S.

Rating system: UWB symbol. Ratings are given on a 1-5 scale, with five being the highest.

2022 REBUTTEL CHARDONNAY, REBUTTAL

WINERY, Manteca, Calif., \$6.99 U.S., 13.5% ABV The Rebuttel 2022 Chardonnay emerges as a testament to timeless craftsmanship and a nod to modern sophistication. This wine beckons with promises of lush fruit, intricate layers, and a lingering finish, inviting enthusiasts to embark on a sensory journey through its delicate intricacies. In the

glass, the Rebuttel chardonnay presents itself with a luminous straw hue reminiscent of golden sunlight dancing through a springtime orchard. Its clarity suggests purity, hinting at the meticulous attention to detail that went into its creation. The bouquet unfolds on the nose with the first gentle swirl, releasing an enchanting aroma medley. 
